SUMMARY:

Provides all aspects of well and sick childcare in the pediatric clinic, and assists as needed in Quality Assurance assessments.

- Provides urgent care as indicated.
- Appropriately documents all findings concisely and completely utilizing the electronic medical records system. Uses all forms correctly. Entries are dated and signed. Documentation must be legible.
- Offers medical advice by telephone to parents of pediatric patients as part of a 24-hour call rotation with other providers.
- Participates in specific programs of the clinic as assigned by the Chief Medical Officer.
- Serves as a consultant for nurses and other staff members handling triage calls or walk-ins.
- Assists in education of patients, residents, nurses, nurse practitioners, medical students, and other staff.

Participates in Quality Assurance assessments periodically.

Participates in clinic and staff meetings and other duties as assigned by the Chief Medical Officer.
